\*Generali Balanced Managed fund is an umbrella fund to achieve long-term capital growth and income. This fund invests in all other funds detailed above, with the exception of the Money fund. The AMC Fee rate was calculated as the weighted average for the funds the Balance Managed fund is invested in.

The charges are approximately split 60% for administration services and 40% for investment management.
